
The **"Technical Development Adversarial Company List"** is a summary table of adversarial trials (such as invalidation trials or opposition) categorized by company.

This list is divided into two sections: (1) Attacking Side and (2) Defensive Side. Trials where the company is attacking another company (or individual) are listed under (1) Attacking Side, and trials where the company is being attacked by another company (or individual) are listed under (2) Defensive Side.

*As of the data update date, the list includes trials requested within the past 10 years, as well as those involving patent rights that are still valid.

Entries are arranged in order of most recent trial numbers.

- ④ Type of Trial, displayed as an abbreviation. The abbreviations and their meanings are as follows:
 "異議(Opposition)" = Opposition filing "一部異議(Partial Opposition") = Partial opposition filing "無効(Invalidation)" = Invalidation trial
 "一部無効(Partial Invalidation)" = Partial invalidation trial "判定(Determination)" = Determination
- ⑤ Trial Identification Number assigned by the patent office to the trial requested.
- ⑥-1 Information on the petitioner (including any joint petitioners), such as the company or individual requesting the trial. Listed companies are shown with their securities code, while unlisted companies or individuals are labeled as "未上場(Unlisted)." Company and individual names are as they were at the time of the trial request.
- ⑥-2 Information on the company (or individual) requesting a trial against the company. Listed companies are shown with their securities code, while unlisted companies or individuals are labeled as "未上場(Unlisted)." Company and individual names are as they were at the time of the trial request.
- ⑦-1 Information on the opposing party (company or individual) against whom the company requested a trial. Listed companies are shown with their securities code, while unlisted companies or individuals are labeled as "未上場(Unlisted)." Company and individual names are as they were at the time of the trial request.

⑦-2 Information on the respondent (including any joint respondents) as the company or individual subject to the trial. Listed companies are shown with their securities code, while unlisted companies or individuals are labeled as "未上場(Unlisted)." Company and individual names are as they were at the time of the trial request.

- (8) Specific information on the patent rights of the opposing company that were subject to the trial request.
 - "特許番号(Patent Number)" = The identification number of the patent assigned by the patent office.
 - "発明の名称(Title of Invention)" = The title of the patented invention.
 - "YKS技術業種分類コード・名称(YKS Technology Industry Classification Code/Name)" = The subclassification code and name in the YKS technology industry classification to which the patent belongs. A single patent may belong to multiple subclasses.
- (9) Information on the trial results. The abbreviations and their meanings are as follows:
 - "不成立(Not Established)" = The patent rights are maintained.
 - "成立(Established)" = The trial request is established, and in the case of an invalidation trial, the patent rights are extinguished. In the case of a Hantei (Advisory Opinions on the Scope of a Right), the conclusion is as claimed by the petitioner.
 - "一部成立(Partially Established)" = The trial request is partially established, and in the case of an invalidation trial, part of the patent rights is extinguished. There is no partial establishment in the case of a Hantei (Advisory Opinions on the Scope of a Right).

"却下(Dismissed)" = The request itself was not upheld.

"請求取下(Withdrawal of Request)" = A request was initially made, but the trial was withdrawn due to the petitioner's circumstances. "審判中(Under Trial)" = The case is still under review by the patent office, and no conclusion has been reached.
