- ① 作成日(Creation Date of this List) and データ更新日(the Date of Data Used for Creation).
- ② YKS Technology Industry Classification.Subcategory Code and Subcategory Name.
- ③ Sorting Number on this List.A smaller number indicates a more recent trial request (attack).
- ④ Type of Trial.Displayed in abbreviation. The abbreviations and their meanings are as follows:  
 "異議(Opposition)" = Opposition "一部異議(Partial Opposition)" = Partial Opposition "無効(Invalidation)" = Invalidation Trial  
 "一部無効(Partial Invalidation)" = Partial Invalidation Trial "判定(Judgment)" = Judgment
- ⑤ Identification Number Assigned by the Patent Office for the Requested Trial.
- ⑥ Identification Information of the Company (or Individual) that Initiated the Trial Request.  
 証券コード(Securities code), 会社名(company name (or individual name)).  
 Listed companies show their securities code. Unlisted companies or individuals are marked as "Unlisted."  
 The securities code and name are as recorded at the time of the trial request.  
 Note that there may be multiple requesters in cases where joint requests are made by consolidated subsidiaries or related companies.

⑦ Identification Information of the Company (or Individual) that has been requested for a trial.

証券コード(Securities code), 会社名(company name (or individual name)).

Listed companies show their securities code. Unlisted companies or individuals are marked as "未上場(Unlisted)."

The securities code and name are as recorded at the time of the trial request.

Note that there may be multiple requesters in cases where joint requests are made by consolidated subsidiaries or related companies.

⑧ Specific information on the rights subject to a trial request received by the respondent from the petitioner.

"特許番号(Patent Number)" = The identification number of the patent assigned by the patent office.

"発明の名称(Title of Invention)" = The title of the patented invention.

"YKS技術業種分類コード・名称(YKS Technology Industry Classification Code/Name)" = The subclassification code and name in the YKS technology industry classification to which the patent belongs. A single patent may belong to multiple subclasses.

⑨ Information on the trial result. Each abbreviation and its meaning are as follows:

"不成立(Not Established)" = The patent rights are maintained.

"成立(Established)" = The trial request is established, and in the case of an invalidation trial, the patent rights are extinguished. In the case of a determination request, the conclusion is as claimed by the petitioner.

"一部成立(Partially Established)" = The trial request is partially established, and in the case of an invalidation trial, part of the patent rights is extinguished. There is no partial establishment in the case of a determination request.

"却下(Dismissed)" = The request itself was not upheld.

"請求取下(Withdrawal of Request)" = A request was initially made, but the trial was withdrawn due to the petitioner's circumstances.

"審判中(Under Trial)" = The case is still under review by the patent office, and no conclusion has been reached.
